SARA Policy in Effect

- In an email sent to SARA contacts March 13, 2025 NC-SARA shared that effective January 1, 2026, one of the approved policies from the 2024 SARA Policy Modification Process (PMP), [PMP24-0619: Responsibilities for Resolving Complaints](#), expands on an existing requirement for all SARA-participating institutions. Please review our previous message and reference the [SARA Policy Manual](#) (Section 4.4.a).
- **Coming soon!** - a new version of the application and approval form for institution participation in SARA, effective July 1, 2025. This will primarily reflect [PMP24-0630 Aligning Professional Licensure Disclosure Requirements](#), language for which can be found in the [SARA Policy Manual](#) (Section 5.2). An email to all institution contacts will be sent in the middle of May to inform you that the new application is available on the [NC-SARA website](#) and to provide guidance on when to use it. NC-SARA will temporarily post a “redlined” version to bring your attention to the changes. The latest institution application and any relevant guidance is always available on the following page of the [NC-SARA website](#).

Please note, an institution only needs to complete the application once a year at the point of your annual renewal for SARA participation.

2025 NC-SARA Data Reporting

It's almost time for the SARA annual data collection/reporting. The SARA data reporting window this year will be **May 15 – June 15**. The data reporting process has been improved. Update on SARA Institutional Closures Working Group

The [SARA Institutional Closures Working Group](#) was created to consider SARA-wide institutional closure requirements that will allow for a strategic, structured, and transparent process for managing closures of SARA-participating institutions, prioritizing the interests of students while ensuring regulatory compliance and maintaining institutional integrity. To be more effective, the group decided to break up into three subcommittees: teach-out plans/agreements; financial arrangements; and academic records (records retention). The subcommittees meet regularly, and the teach-out agreement subcommittee has submitted a [proposal](#) (PMP25-0746) for the 2025 SARA Policy Modification Process.
